

The Coronavirus Response and Relief Supplemental Appropriations Act, 2021 (CRRSAA) and American Rescue Plan Act, 2020 (ARP), which provided funds for student and institutional assistance, requires that certain information be posted for the public.

- 1. An acknowledgement that the institution signed and returned to the Department of Education the Certification and Agreement and the assurance that the institution has used the applicable amount of funds designated under the CRRSAA and ARP (a)(1) and (a)(4) programs to provide Emergency Financial Aid Grants to Students.** We have signed and returned the certification and agreement, and will use the applicable amount of funds on emergency financial aid grants to student.
- 2. The total amount of funds that the institution will receive or has received from the Department pursuant to the institution's Certification and Agreement for Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.** Total allocation to Rend Lake College for Emergency Financial Aid Grants to Students under the CRRSAA - \$591,132. Total allocation to Rend Lake College for Emergency Financial Aid Grants to Students under the ARP - \$2,417,055.
- 3. The total amount of Emergency Financial Aid Grants distributed to students under the CRRSAA and ARP (a)(1) and (a)(4) programs as of the date of submission (i.e., as of the initial report and every calendar quarter thereafter).** Total amount distributed (CRRSAA) as of 9/30/2021: \$591,132. All CRRSAA funds have been distributed. Total amount distributed (ARP) 10/1/2021-12/31/2021: \$1,211,351. Total amount distributed (ARP) 1/1/2022-3/31/2022: \$1,205,704. Total cumulative ARP distribution: \$2,417,055. All ARP funds have been distributed.
- 4. The estimated total number of students at the institution that are eligible to receive Emergency Financial Aid Grants to Students under the CRRSAA and ARP (a)(1) and (a)(4) programs.** For the spring 2021 semester (CRRSAA), there were an estimated 466 eligible recipients. For the summer 2021 semester (CRRSAA), there were an estimated 171 eligible recipients. For the fall 2021 semester (ARP), there were an estimated 478 eligible students. For the spring 2022 semester (ARP), there were an estimated 463 eligible students.
- 5. The total number of students who have received an Emergency Financial Aid Grant to students under the CRRSAA and ARP (a)(1) and (a)(4) programs.** For the spring 2021 semester (CRRSAA), 466 students received Emergency Financial Aid grants. For the summer 2021 (CRRSAA) semester, 171 students received Emergency Financial Aid grants. For the fall 2021 semester (ARP), 478 students received Emergency Financial Aid grants. For the spring 2022 semester (ARP), 463 students received Emergency Financial Aid grants.
- 6. The method(s) used by the institution to determine which students receive Emergency Financial Aid Grants and how much they would receive under the CRRSAA and ARP (a)(1) and (a)(4) programs.** The CRRSAA distribution of \$191,678 was divided among Spring 2021 PELL eligible students based on qualifying percentages (full-time, $\frac{3}{4}$ time, half-time, less than half-time). The CRRSAA distribution of \$399,454 was divided among Summer 2021 PELL eligible students based on qualifying percentages (full-time, $\frac{3}{4}$ time, half-time, less than half-time). The

ARP distribution of \$1,211,351 was divided among fall 2021 PELL eligible students based on qualifying percentages (full-time, ¾ time, half-time, less than half-time). The ARP distribution of \$1,205,704 was divided among spring 2022 PELL eligible students based on qualifying percentages (full-time, ¾ time, half-time, less than half-time).

7. Any instructions, directions, or guidance provided by the institution to students concerning the Emergency Financial Aid Grants. Recipients received the following email:

Dear Rend Lake College Student:

Rend Lake College will be distributing the student portion of funding received under the American Rescue Plan (ARP). Within the next week you should be receiving a refund in the account that you have established with BankMobile. Despite receiving a refund, if you have an outstanding balance for Spring semester you are still responsible for that balance. ARP funds are not permitted to be applied to past due balances.
