

ACCEPTANCE OF BID FOR AUDIT SERVICES FOR FISCAL YEARS 2025-2027 (TO BE PROVIDED)

Rend Lake College Board of Trustees

March 11, 2025

RECOMMENDATION: To accept the bid from Sikich CPA LLC of Naperville, IL for audit services for Rend Lake College District 521 and the Rend Lake College Foundation for the fiscal years 2025-2027.

RATIONALE: The College received three proposals from audit firms in response to our recent request for audit services. After careful review, Sikich CPA LLC submitted the most competitive bid which aligns with the College's overall needs including comprehensive financial oversight, compliance with regulatory requirements, and a thorough evaluation of internal controls. Below is a summary of the bid results from the opening held on March 10, 2025. The College and Foundation received pricing for their individual audits, and the Foundation will be responsible for the payment of their services, which includes filing of any state and federal tax returns.

Rend Lake College has had at least two major federal programs for Single Audit purposes in 7 of the last 8 fiscal years.
