
REND LAKE COLLEGE STUDENT ACHIEVEMENT WINNERS NAMED

Over the past several days, I have discussed with many RLC students the mandatory ten dollar activity fee. I have heard many comments and ideas from the students about the fee and other events happening on this campus.

To begin with, the ten dollar activity fee is controlled by the Student Senate. The Senate divides this fund among the athletic department, drama, Tarn, The Pressing Times, and the Senate itself which spends its money for dances and movies for the

I think that this activity fee should be totally done away with or else the cost of it should be cut in half. A minority of students benefit from this fee while the majority of students must pay it and receive nothing in return. Some may say that it is the students' fault that they do not take advantage of these dances, movies, and athletic events; however, it should be the students' choice whether they want these activities, and if they don't, then the activities should be dropped, and likewise the activity fee should be decreased.

Also a recent incident was mentioned to me by some members of the Student Senate and asked for funds which would be used toward the paying of entry fees in competitions where this club represents Rend Lake College against other colleges. Why don't the clubs on campus receive any financial help through the use of this fund? Are they not considered "student activities.?

At John A. Logan, the Student Senate gives each new club \$150 to begin its treasury. Why can't this be done at RLC?

It is also my understanding that a few clubs have requested permission to have a pin ball machine placed in the new student center. This action was also denied. There is no doubt in my mind, that a pinball machine would be a greater benefit to the student body that the dances which few people attend.

The Student Senate also approved a program which will entitle people 55 years and older in this district to receive a complimentary card which will allow them to attend any RLC activity free. I would like to know why the student body must pay ten dollars for the same thing and not attend anything? Also the cost of these cards, the mailing, the research which will be required to get all of the names needed, and the cost of paying employees to do this work will be tremendous.

The visitation team from the North Central Association of Colleges and Secondary Schools was on the RLC campus Wednesday, Thursday, and Friday last week.

Rend Lake was granted accreditation five years ago and is up for review this year. In preparation for the team visit and the review, the total college was involved last semester in writing an institutional Self Study which members of the review team read before coming on campus.

Basic Grant

Rend Lake College students can still apply for Basic Educational Opportunity Grants. Six of our local students have already received awards for as much as \$452. The cash does not have to be repaid and is granted in addition to other scholarships or aid that eligible students receive. Enrollment

The total head count at RLC for this semester as compared with last semester shows an increase from 1,279 to 1,302 for this semester.

There are 431 freshmen and 209 sophomores students which are full-time. Freshmen women total 220 while the freshmen men are a little under this quota with 211. There are 150 sophomore men and 59 sophomore women. The above quotas are for full-time students only. The total number of full-time students is 640.

Students enrolled in evening classes add up to 573. In the 573 evening students are 338 freshmen, 93 sophomores, and 142 unclassified.

Warriors End Season

RLC closed out their conference record at 6-4 with a 98-91, double overtime loss to the Shawnee Saints on February 14 at the Cairo High School.

Fighting for a second place tie in the conference, RLC displayed fine shooting in the first stanza as they ripped the nets at a 55 per cent clip, while Shawnee was hitting 38 per cent. But the Saints managed more shots from the field and the game stood deadlocked at 38-38 at the half-time break.

The game remained relatively close throughout the second half except for an 11 point Shawnee lead with 12:40 remaining. The Warriors then managed to whittle down that lead and finally tie it up at 74-74 with a basket by Dennis Nehrkorn at the end of regulation play.

The first overtime thus resulted in a swapping of baskets and again the contest remained tied at 82-82 at the end of the first overtime period. The second overtime saw Shawnee grab a quick four point lead and the Saints' Calvin Johnson settled the issue with some hot outcourt shooting late in the contest.

The Rend Lake Warriors had their 1973-74 basketball season come to an abrupt halt on February 18, as they were defeated by Kaskaskia College 91-85 in the opening round of the NJCAA Section VIII tourney at John A. Logan College.

The Warriors had previously beaten the Blue Devils 86-78 and 105-72 earlier in the year but this time the tables were turned as KC stayed close throughout the first half and only trailed the Warriors 49-46 after the first 20 minutes.


